

**ORDER CANVASSING RETURNS AND DECLARING RESULTS OF THE
BENBROOK WATER AUTHORITY
NOVEMBER 2, 2021, ELECTION OF DIRECTORS**

WHEREAS, on November 2, 2021, an election was held for the election of three (3) directors on the Benbrook Water Authority (“Authority”) Board of Directors;

WHEREAS, the votes cast at the election have been counted and recorded on the official election returns, and said returns have been certified and filed with the Authority by the Tarrant County Elections Administrator; and

WHEREAS, the election was called and held in all respect under and in strict conformity with the Constitutions and laws of the State of Texas and the United States of America.

NOW, THEREFORE, BE IT ORDERED BY THE BENBROOK WATER AUTHORITY BOARD OF DIRECTORS THAT:

Section 1. The November 2, 2021, election was ordered and notice given in accordance with state law; the election was held in conformity with all applicable laws; and the returns of the election have been made by the proper officials of Tarrant County. The corresponding tabulation of election returns required by Section 67.004 of the Texas Election Code is attached hereto as Exhibit A, which is incorporated herein for all purposes.

Section 2. The Authority election has resulted in the election of Dave Clark, David Hafer, and Rick Whitehurst.

Section 3. The canvass meeting at which this Order has been considered and adopted is open to the public as required by law, and written notice of the time, place, and subject matter of the meeting, was given as required by Section 551, Texas Government Code. The canvass of the Authority’s election returns was conducted in accordance with the requirements of Chapter 67 of the Texas Election Code, including but not limited to the requirement to conduct the canvass during the timeframe set forth in Section 67.003(b) of the Texas Election Code.

Section 4. The Authority Board of Directors, Authority staff, and legal counsel are hereby authorized to take all necessary actions to implement this Order and to ensure compliance with the Texas Election Code.
